CANCELLATIONS

The Hirer may cancel or change the booking by notifying Riverland Gymnastics Academy at least 48 hours before the use of the facility is to take place.

Where the Hirer fails to attend a booking or has not provided advance notice of cancellation or change, the Hirer will incur a cancellation fee of 100% of the hire fees.

If due to unexpected circumstances the Riverland Gymnastics Academy is unavailable for the Hirer's booking, a refund or change of date for the booking can be made.

TERMS & CONDITIONS OF HIRE

- a) The Hirer acknowledges that the Contact Person listed on the Application Form accept the responsibility for the hiring and condition of the facility during the hire period.
- b) The Hirer is responsible for the behaviour of all members/guests using the facility and must control their conduct to be orderly and reasonable.
- c) Any use of the Riverland Gymnastics Academy, which is a violation of any laws, shall be a violation of the agreement and shall be grounds for immediate termination of the same.
- d) Any person, whose conduct is objectionable, disorderly or disruptive to the Riverland Gymnastics Academy or in violation of any law, shall be refused entrance or shall be immediately ejected from the Riverland Gymnastics Academy.
- e) The Hirer must comply with any reasonable direction of the Riverland Gymnastics Academy in connection with the safe and proper use of the facilities.
- f) The Riverland Gymnastics Academy Staff Room/Office is out of bounds.
